Understanding the Frenzied Dance of Art and Violence

There seems to exist a natural interrelationship between art and violence—while creativity often emerges from aggressive impulses, art-making, in turn, helps mitigate aggressive and violent energy.

This workshop will explore this frenzied dance by clarifying this interrelationship-and indeed, how messy and complex it can become—with the ultimate aim of providing mechanisms from which art therapists can benefit when working with volatile populations. To do so, it will draw from historical examples of well-known artists who have violent tendencies, those whose works emerged from violent experiences and the expressions of the most notorious offenders who's works perpetuated their psychopathic cycles.

In addition, it will provide narratives that emerged in working with artists who are incarcerated for their heinous crimes, as well as reflect on personal experiences as an art therapist with violent offenders and aggressive clients. These discussions will be followed by simple yet powerful art directives that the facilitator has often used to explore and mitigate aggressive and impulsive tendencies. Ultimately, this workshop will emphasize and underscore through these vignettes how art emerges from - and how art therapy techniques may assuage aggression and violence.

Re-Creating Identity: Arts and Art Therapy with the Imprisoned

Prisons are known for being therapeutically impoverished where security is instituted through the systematic objectification of the inmates. Identity is stripped away - inmates are given a number and uniform, reinforcing their loss of self, ultimately disempowering and dehumanizing them for control. This is clearly detrimental to success. Inmates may often rebel against such control, even becoming violent, manipulative, or simply apathetic. They might also acquire or maintain debilitating mental health symptoms such as depression and various levels of psychoses.

Art therapy has been demonstrably valuable in mitigating this. The first part of this workshop will consist of a brief presentation and discussion that will rely on the perspectives of Social Interaction and Labelling Theory to explore the benefits of art and art therapy in corrections through: illustrations from established arts and art therapy programs; perspectives from inmates and correctional art therapists; and results of several published and ongoing research studies. Ultimately, it will emphasize how art therapy overcomes personal and institutional barriers to mitigate mental illness, facilitate wellness and re-create new identities for those in prison. This will be followed by a simple yet powerful art directive that the facilitator has often used to begin the process of exploring sense of identity with many of the men and women he has worked with inside. Ultimately, those who attend this workshop will begin to recognize the power of art in demarginalizing the marginalized and rehumanizing the dehumanized.

David E. Gussak, PhD, ATR-BC, HLM is Professor for the Florida State University's Graduate Art Therapy Program and Project Consultant for the FSU/FL Dept of Correction's Art Therapy in Prisons program.


He has presented and published extensively internationally and nationally on forensic art therapy and art therapy in forensic and carceral settings. These include, amongst others, *Art on Trial*:

He currently serves on the editorial board for several publications including Art Therapy: The Journal of the American Art Therapy Association and Arts in Psychotherapy.

In 2022, Dr. Gussak was granted the American Art Therapy Association's Honorary Lifetime Member (HLM) award.
